Of the 18 current NCDO members, 10 have Men's and Ladies' Teams, 4 have Men's Teams, 2 have Ladies' Teams and 2 have neither.

Additional Important Notes:

Matches start at 2:00 p.m. and must be played on at least 3 boards (more boards can be used if available).

See NCLC Rules regarding rescheduled matches.

Call the opposing captain at least 5 days prior to the match date to confirm that the match will indeed be played as scheduled, and to obtain any necessary directions.

A player must play in at least half of her team's matches to qualify for tournament play. That minimum is 4 matches for NCLC.

As per league rules, forfeits this season will carry a score equal to last season's average winning total. Therefore, NCLC forfeits will be scored 16-0.

The same seven-day deadline applies to the e-mailed scan option.
